## Agency Grant Policy and Request

### Overview

The Financial Oversight Committee (FOC) manages the annual operating budget. At the close of each fiscal year, the Controller and Treasurer report ending account balances.

The FOC reviews current and anticipated needs against those balances and may:

1. Instruct the Controller to transfer all or a portion of any available operating fund balance amounts to the Treasurer for re-investment in the Meeting's endowment accounts.
2. Determine Agency recipients and amounts to be disbursed from operating surplus and unspent endowment income per the Agency Grants Policy and recommend same to Monthly Meeting for approval.
3. Determine another use for the funds and submit a recommendation to Monthly Meeting for approval.

This policy documents the processes and policies associated with option 2 above.

The FOC is responsible for receiving and vetting requests and potentially awarding grants to agencies that support Quaker oriented social impact goals. Grants are NOT based on financial need; however, Members should thoughtfully consider any application in terms of the Meeting's available funds. This policy is intended to broadly define the parameters for the types of agencies to be awarded grants and to create equitable processes for the application and awarding of same.

### Definitions

**Member** – Newtown Monthly Meeting defines membership as any person who joins based on an approved membership application or transfer of a valid membership from another Meeting, or whose parents' requested membership for them at birth. Membership is retained absent a request for release or transfer of membership. Newtown Monthly Meeting seeks to align with the membership guidelines established in Philadelphia Yearly Meeting Faith and Practice, which leaves final decisions to the Monthly Meeting.

**Valid Agency** – The FOC currently defines this term to cover agencies (typically nonprofits) engaged in positive social impact initiatives that provide and nurture key tenets of Quakerism e.g., peace and justice, food equity, poverty relief, eldercare, education, etc.

There is an expectation that Members directly associated with grant recipients will deliver a brief report to Meeting for Business that describes how the agency uses grant money and its positive impact on the community. The Treasurer is responsible for overseeing compliance with these reporting requirements.

### Application Process and Reporting

- Members should submit a completed request to the FOC Clerk (FOCclerk@newtownfriendsmeeting.org). There is an expectation that a Member applying is familiar with the specific Agency they are nominating for a grant.
- Applications will be accepted between August 1st and May 31st in order for the FOC to review them at a subsequent regularly scheduled meeting.
- Reminders of the application window will be placed in the newsletter and may be announced at the winter and spring Monthly Meetings. YTD submitted applications will be reported via the website.
- **Members are limited to one approved request per fiscal year (July 1 – June 30)**

Camp Onas is currently engaged in two major funding initiatives. The first is our **Camp Onas Capital Campaign**. We hope to raise enough funds for two purposes. The kitchen needs modernizing and expansion ... the kitchen feeds over 200 hungry campers and staff three times a day, compared to the 150 appetites it was designed to feed. We also want to build the endowment for our Camper Aid Fund, the equivalent of scholarships. We annually seek gifts for that Fund to support Quaker families, and campers who strengthen our community's diversity.

The second, and more immediate initiative is raising the money to build **two new Showerhouses** to replace the aging structures that were built over 50 years ago, and which are now in constant need of remedial care and repair. As planning for this project evolved, awareness of specific needs were built into their design:

- Expansion (Camp has grown from 150 campers each session to slightly over 200),
- Safety (in light of recent tornado activity in Ottsville and other factors, a secure place for campers to shelter-in-place)
- Greater privacy for the users – new toilets are in fully enclosed stalls, and every shower has its own private dressing space
- Greater energy efficiency and water use reduction

Since the planning and design phase has passed, a number of factors have pushed the cost of the project significantly higher, including and not limited to inflation of materials and labor costs. Our original intention was to use money that we had budgeted/set aside, to seek out grants and targeted donations, and to finance the balance (our bank has assured us of loan worthiness). The \$1000 donation that Newtown Friends Meeting made last year was for that purpose.

When the Coronavirus pandemic threatened, we carefully considered options, and ultimately determined that we needed to stay closed for the summer of 2021. That didn't eliminate all costs, of course. We made it through that closure, and in the summer of 2022 we ran a carefully planned reduced capacity program. Thankfully, no one got sick, and the Camp community was filled with joy and enthusiasm for the return. We anticipate a nearly fully restored program this coming summer (and are very close to being fully enrolled). We are still seeking grants and donations to help with the cost of the Showerhouse project. For a number of years (to the best of my knowledge) NMM made contributions of \$500 or less. Individuals in the Meeting have also made significant donations. Understanding that last year's donation to Camp Onas from Newtown Friends Meeting was exceptionally large, I would still like to request a similar amount (\$1000) this year. We still hope to raise enough through grants and donations to make the mortgage as manageable as possible, in spite of all the economic forces that seem to conspire against it.

Friends Camp Association of Pennsylvania, Inc., a nonprofit corporation, owns and operates Camp Onas: a camp, outdoor education facility, and retreat center.

Friends Camp Association strives to be a faithful steward of its heritage, people, land and other resources based on the Quaker belief of that of God in everyone.

Onas is a caring community where individuals are nurtured and encouraged spiritually and group unity is fostered through recreation and education in a peaceful and simple environment.

The testimonies designated by the SPICES acronym are overtly and intentionally stressed. Activities and attitudes which build a diverse, interdependent community are daily the norm. Grant Justification: Describe Agency Mission and Alignment with NMM.

**Right Sharing of World Resources** is an independent Quaker organization whose mission, values and goals are completely congruent with those of NMM.

**Proposal:**

The Peace and Social Justice Committee proposes that Newtown Friends Meeting donates \$6,500 to sponsor a Right Sharing of World Resources project.

We propose that Newtown Monthly Meeting fund a RSWR project because of the value, efficiency and multiplying effects of these investments. We believe the combined impact of enabling people in poverty-stricken areas to meet their most basic human needs and to gain some control over their lives, while simultaneously benefiting others and building community is an investment we should make.

We have an opportunity as a community to take a large step in bringing our actions into closer alignment to our values, as we seek to "Walk cheerfully across the earth, answering that of God in every person."



## **RSWR Mission:**

### **Goal 1**

To provide resources for marginalized women in developing countries to improve the quality of life for the women in a sustainable and self-determined way.

### **Goal 2**

To provide opportunities for those blessed with material resources to explore the burdens of materialism, the power of enough, and global responsibility, and to promote balanced sustainable lifestyles and sharing from abundance.

## **RSWR Work & Values:**

### **Right Sharing:**

We encourage everyone to share their abundance.

### **Partnership:**

We work in partnership with organizations in Kenya, India, Sierra Leone, and Guatemala to improve the quality of life for entire communities.

### **Empowerment:**

We support marginalized women to make decisions that improve their own lives and the well-being of their families and communities.

### **Stewardship:**

Our work is grounded in a sense of stewardship for the world's material, human and spiritual resources.

### **Integrity:**

We practice openness and accountability in our relationship with one another, our partner organizations, and those who support our work.

## **How RSWR Projects Work:**

RSWR works by providing small grants to groups of impoverished women who then make microloans to their members to engage in start-up, income generating businesses, through community self-help initiatives.

Each group of women is required to be small (15-35), audited, with little or no access to other funds, inclusive of village, tribal, religions, and other divisions. For example every group in India must include both Muslims and Hindus to be eligible for RSWR grants.

Each member of a group must be committed to two things: 1) helping each other succeed in their local businesses, and 2) making sure that each woman repays her loan so money is available for other group members to get loans to fund more businesses.

RSWR staff in each county assist the groups with applications for funds and provide financial and organizational expertise after groups receive grants.

### **Execution of RSWR Projects:**

- 1) Groups of women submit detailed business plans for a seed grant;
- 2) The Board of RSWR selects the groups to receive the grants (funded by donations to RSWR);
- 3) The groups then loan money to their individual members to run microbusiness ventures;
- 4) The women run their businesses, generate income and pay back their loans with interest to the group;
- 5) The group then uses the repaid money to make more loans to other women to fund more businesses.

RSWR staff in each country assist the groups with applications for funds and financial and organizational expertise after groups receive grants.

Each group receives only one group from RSWR and continues to expand with loans to other group members as initial loans are paid back to the group, thus providing a strong incentive for all members to help each business begun with an individual loan succeed. The group then uses the repaid money to provide additional loans to members to start their new businesses and to keep the funds recirculating again and again.

The payback rate of the RSWR loans is a remarkable 95%.

### **Example of Projects:**

Pennswood Village's current RSWR project is enabling individual women to undertake businesses in fish mongering, buying and selling cereals, selling second-hand clothes and shoes, grocery kiosks, vegetable and fruit stalls, and milk vending. Each individual will borrow \$108 from the group at 10% interest and repay the group in twelve months. The money will then be relented to others for their businesses and recirculated again and again.

### **Educational Benefit:**

This project has the potential to be particularly valuable for our younger people. The opportunity to follow first-hand reports of the specific setbacks and successes of a small group of people as they build start-up businesses in poverty-stricken areas while learning to work together, in a different cultural setting provides a unique opportunity.

### **Strengthening Quaker Institutions:**

Currently RSWR relies heavily on individual donations to sustain its work. At this point only 10% of its income comes from institutions. An increase in RSWR's ability to rely on regular budgetary support from Quaker Meetings would enhance its ability to do long-term planning.

If Newtown Friends Meeting were to decide to fully fund a RSWR project this year, the experience and feedback our community would gain could enable us to work with other Quaker Meetings in our area to build support for RSWR into their regular budgets as well. This would enhance RSWR's ability to perform its mission.

Deep thanks to NFM for supporting refugee families through the work of BCICRR. Last year, if I recall correctly, the meeting provided one month's rent of \$1900 for the Afghan refugee family now settled in Morrisville. I am pleased to report that they are doing well. The head of household is well employed and our rent subsidy to them is now only \$900 per month. They are able to manage all their other financial obligations. The two Syrian families who came to us six years ago are now completely independent of our financial support. One family has purchased a home in Levittown.

Our work's alignment with NMM, in a spiritual sense is that it arose in a leading during worship at NMM. In a moral sense it is a statement of respect and acceptance in the face of distrust and rejection of immigrants and asylum seekers and a testimony to the oneness of all humankind.

This year, BCICRR's mission is shifting. We find that we, as an unincorporated group of individuals, don't have the administrative strength to take on the varied tasks of sponsorship of a refugee family. While we will continue to support the Afghan family for another 2-3 years, we are undertaking to collaborate with two other Bucks County immigrant serving organizations to bring services to our part of Lower Bucks. If the meeting were able to repeat its gift of \$1900 it would be a great boost as we enter into this new
